The Directorate-General of SASKİ, the Samsun Waterworks and Sewers Administration (hereinafter referred to as "Employer") invites experienced companies and joint ventures formed by companies to the tender regarding the Samsun Wastewater Project "The Design and Construction Works of and 3-Year Operating Services for the Eastern Advanced Biological Wastewater Treatment Plant and Deep Sea Outfall" (hereinafter referred to as the "project").

The Directorate General of Samsun Waterworks and Sewers Administration (SASKİ) has obtained loans from the European Investment Bank (EIB) and the KfW (Kreditanstalt für Wiederaufbau) bank group of the government of the Federal Republic of Germany for financing the design and construction part of the Samsun Wastewater Project, and shall use these loans for the design and construction services for the Samsun Eastern Advanced Biological Wastewater Treatment Plant and Deep Sea Outfall works. The price for the 3-year operating and maintenance services within the scope of the tender shall be obtained from the Employer's own equities.

The tender shall be conducted in accordance with the rules and procedures of the European Investment Bank and Kreditanstalt für Wiederaufbau.

For this reason the tender for the design and construction of and 3-year operation works for the Eastern Advanced Biological Wastewater Treatment Plant and Deep Sea Outfall shall be international. The Contract for this work shall be based on FIDIC Design, Build and Operate (FIDIC Golden Book).

The main design criteria for the Wastewater Treatment Plant are as follows:

Completion term of the Design-Construction Work: 30 months

Operating and Maintenance Term: 3 years + 2 years optional SASKİ invites all domestic and international companies and joint ventures with adequate experience for the above work to make tenders.

Applicants must have the design, construction and operating experience required by the said project and must prove that they meet the requirements specified in the tender documents and that they possess adequate expertise, experience and financial power to complete the project successfully.

Bidders must meet the following minimum requirements to qualify for participating in the tender:

- 1) Foreign bidders participating in the tender are invited to cooperate with qualified Turkish Companies.
- 2) Bidders may not make tenders as consortiums. If consisting of more than one companies, the bidders must form joint ventures.
- 3) The average turnover of the bidder for the last three years (2007 2009) must be at least 20 000 000 Euros or the equivalent.

The yearly average of the 3-year total turnover of the Leading Company must be 10 000 000 Euros or the equivalent,

The yearly average of the 3-year total turnover of each of the other partners must be at least 5 000 000 Euros.

- 4) The bidder shall submit a letter of interest obtained from the Export Credit Agency signifying its consent to provide an ECA guarantee for financing goods and services purchases of up to 6 000 000 Euros. The requirements can be found in the tender documents and shall be consistent with the Arrangement on Officially Supported Export Finances (OECD consensus regulations). For which Commercial Interest Reference Rate the ECA guarantee is available and convertible must be stated as well as the currency. The guarantee must indicate KfW as beneficiary and must be acceptable to KfW.
- 5) Within the last 10 years (2000-2009) it shall have;
- a) Carried out the works for at least two biological urban wastewater treatment plants with a minimum capacity of 25 000 m³/day or the capacity increase by minimum 50 000 m³/day of at least two existing biological urban wastewater treatment plants,

Note: Membrane technology shall not be accepted.

- b) Completed at least one deep sea outfall from shore with a length of 1000 m, a minimum diameter of 500 mm, and minimum 10 m depth at the diffuser end, or at least one deep sea outfall from shore with a length of 500 m, a minimum diameter of 500 mm, and minimum 15 m depth at the diffuser end.
 Note: Lake and river crossing shall not be accepted.
- c) Successfully operated at least two similar biological wastewater treatment plant with a minimum capacity of 25 000 m³/day for at least two years within the last 10 years (2000-2009) (those that have completed two years and the terms of which continue shall be accepted).
- d) Designed at least two biological urban wastewater treatment plant with a minimum capacity of 50 000 m³/day or the capacity increase by minimum 50 000 m³/day of at least two existing biological urban wastewater treatment plants.

Note: Membrane technology shall not be accepted.

During the evaluation of qualification bidder's own experience or the subcontractor experience of the bidder under clauses (b, c) shall be considered.

- To be able to participate in the tender the applicants must submit the following documents:

- 3) Certificate of Authorization, Power of Attorney
