The following requirements with respect to the applicant have been added:

a) The applicant shall provide evidence of educational and professional qualification (with dates obtained) and experience on similar projects for the proposed contract director and contract manager;

b) The contract director must have a minimum of 18 years experience on projects which are similar in nature, scale and complexity to the works to be carried out under this project;

c) The contract manager must have a minimum of 12 years experience on projects which are similar in nature, scale and complexity to the works to be carried out under this project.

In providing evidence the applicant shall submit detailed CV's of each proposed candidate.

The applicant shall fail to meet the minimum criteria, if it fails to comply with the criteria above.
