CONTRACT A3.3.1: Construction of Sewerage and Storm Drainage (Samanli Collector) Works

Bursa Water and Sewerage Administration General Directorate (BUSKI) has received a loan from the European Investment Bank (EIB) toward the cost of the 2nd Stage Bursa Wastewater Project. BUSKI intends to apply part of the proceeds of this loan to payments under the contract for CONTRACT A3.3.1: Construction of Sewerage and Storm Drainage (Samanli Collector) Works.

BUSKI now invites sealed "unit priced" bids from eligible bidders for the construction and completion of about 6,3 kms of trunk sewers (300 mm < \varnothing < 500 mm) and 7,75 kms of collectors (600 mm < \varnothing < 1800 mm) within the boundary of Bursa Metropolitan Municipality. The work is expected to require 258.500 m³ excavation, 243.450 m³ fill and 3.250 m³ concreting. The work shall be completed in 30 months.

Interested tenderers are invited to a Site visit at 10.30 on May 13, 2011.

Postqualification will be conducted through the prequalification procedures specified in the EIB's Procurement Guideline and World Bank's Standard Bidding Documents. The minimum criteria, required for postqualification and detailed in the PQ. document to be obtained from BUSKI, are summarized below:

- a) Firm(s) must be functional for at least 5 years.
- b) A minimum average construction turn-over of 10 million EUR (with the Turkish Central Bank exchange rate of 30th June for the relevant year) within the last 5 years
- c) Experience in similar works (min. 8 million EUR value) as prime contractor in at least one contract during the last 10 years.
- d) Documentation for construction experience for at least 6,5 kms of concrete pipe ($\varnothing \leq 500$ mm) in one contract and 8 kms for collectors ($\varnothing \geq 600$ mm) as polyethylene (PE) and/or reinforced concrete pipes and/or reinforced concrete boxes in the same or another contract, and shoring experience, all executed during the last 10 years.
- e) Financial capacity for a minimum of 1 million EUR equivalent cash and credit.
- f) Construction equipment adequate to complete the Works satisfactorily.
- g) Key personnel experienced in similar construction works.
- h) For a joint venture, the minimum shares for the lead and the other partner shall be 55 % and 30 %, respectively. The financial capacity and the experience of the partners must be proportional to their shares, as detailed in the PQ document.
- i) All Bidders shall submit a bid security for 300.000 EUR.
- j) All bidders shall nominate a design subcontractor to perform the engineering and design works in accordance with the requirements in the PQ Document.

Bidders may obtain further information from and inspect the bidding documents at BUSKI (address below) daily from 8:00-16:30. Until the site visit mentioned above, a complete set of documents (either in Turkish or English) may be purchased by interested bidders for a nonrefundable fee of 500 EUR (plus 250 EURO if both Turkish and English copies

are required). Bidders, unable to purchase the documents in person and wishing the documents to be mailed, must add the courier cost to the purchase price. Payments can be transferred to BUSKI' s account IBAN: TR84 0001 2009 2990 002P 0000 20 at Bursa HalkBank Heykel Branch.

Applications for qualification and bidding may be made in either English or Turkish (only for the domestic bidders). The qualification and bid documents should be submitted in two separate sealed envelopes, delivered to the address below by 14:00 hours on May 23, 2011, and be clearly marked "Application for Contract A3.3.1: Construction of Sewerage and Storm Drainage (Samanli Collector) Works." The qualification package shall be opened at 14:30 on the same day in the presence of bidders representatives who choose to attend.

The qualification documents shall be evaluated and the applicants shall be notified of the results with an invitation to the qualified applicants to the opening of the financial envelopes. The financial envelopes shall be opened in the presence of the bidders who attend the opening. The financial offer envelopes of the unqualified applicants shall be returned unopened. From the qualified bidders, the lowest evaluated bid shall be awarded the contract.
