This Invitation for Prequalification follows the General Procurement Notice for this project which was published in "Procurement Opportunities" page in the web site of EBRD on 6 January 2011 with the procurement reference 6275-GPN-40775.

Vodovod i Kanalizacija a.d. Bijeljina (Bijeljina Water and Wastewater Company) (the Employer) intends applying the proceeds of SIDA and EU IPF grants administrated by the European Bank for Reconstruction and Development (the Bank) towards the cost of Design and Construction of Municipal Wastewater Treatment Plant for Bijeljina.

The Employer intends prequalifying firms and joint ventures to tender for the following contract to be funded from part of the proceeds of the loan:

Design and Construction of the Municipal Wastewater Treatment Plant A municipal wastewater treatment plant will be constructed in Bijeljina for a 40,000 population equivalent for the year 2025. The wastewater treatment plant must satisfy all applicable national and EU legal requirements including but not limited to European Council Directive 91/271/EEC concerning urban wastewaters as well as the EU directives for waste water sludge management.

The wastewater treatment plant will be a biological treatment plant based on the Sequencing Batch Reactor (SBR) process. Keeping the biological treatment process as SBR, alternative technologies may be proposed by the Tenderers. The work includes the design of the treatment plant and the access road; the construction of the treatment plant; the access road and electrical and mechanical installations and 2 years of Defects Liability Period. The contract duration will be 18 months plus 24 months of Defects Liability Period.

Prequalification and tendering for contracts to be financed with the proceeds of SIDA and EU IPF grants administrated by the Bank is open to firms and joint ventures of firms from any country.

Prequalification documents may be obtained from the address below. If requested, the documents will be promptly despatched by courier, but no liability can be accepted for loss or late delivery.
