Georgia has received a loan from the European Investment Bank (hereinafter referred to as "the Bank") toward the cost of Water Infrastructure Modernization Project, and it intends to apply part of the proceeds of this credit to payments under the Contract for Supply & Installation of Consumer Water Meters of 15 mm Nominal Diameter for the United Water Supply Company of Georgia (Contract # EIB/WIMP/W/ICB/08).
2. The Municipal Development Fund of Georgia now re-invites sealed bids from eligible and qualified bidders for works: Supply & Installation of Consumer Water Meters of 15mm Nominal Diameter for the United Water Supply Company of Georgia  
The project area is located in all over Georgia in 29 municipalities.  
Project envisages supply and installation of 66,480 units of consumer water meters of 15 mm nominal diameter. This contract is expected to be implemented from November 2011 through November 2012.
3. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the EIB's Guidelines: Guide to Procurement, February 2004 and is open to all bidders from Eligible Source.
4. Interested eligible bidders may obtain further information from Municipal Development Fund of Georgia, Levan Chichinadze, Executive Director, [procurement@mdf.org.ge](mailto:procurement@mdf.org.ge) and inspect the Bidding Documents at the address given below from Monday to Friday 10:00 to 17:00 hours.
5. To be qualified for award the bidder shall meet the following criteria and present the documents to confirm that as a minimum:
  - (a) The minimum required average annual turnover of construction works for the successful Bidder in the last three years shall be: 11.5 mln. Euro;
  - (b) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments shall be: 3.2 mln. EuroA margin of preference for certain goods manufactured domestically "shall not" be applied. Additional details are provided in the Bidding Documents.
6. A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee GEL 300 or equivalent in a convertible currency plus courier expenses if a bidder would like the Bidding documents to be sent by Courier.
