This Invitation for Prequalification follows the General Procurement Notice for this project which was published on the EBRD website, 'Project Procurement Notices' (<http://www.ebrd.com/pages/workingwithus/procurement/project.shtml>) on 29 March 2010.

Engurhesi Ltd, hereinafter referred to as "the Client", intends using part of the proceeds of a Grant from the European Commission (EU/NIF), which is administered by the European Bank for Reconstruction and Development, hereinafter referred to as "the Bank" towards the cost of Enguri/Vardnili HPP Rehabilitation Project.

The Client intends prequalifying firms and consortia to tender for the following contract(s), hereinafter referred to as "the Contract", to be funded from part of the proceeds of the Grant.

The aim of the Contract is to carry out the preparatory works that will provide the access to the construction site and the accommodation/office facilities for the contractors of the Enguri/Vardnili HPP rehabilitation project.

The Enguri HPP and Vardnili HPP Cascade is located in the west Georgia, in Abkhazia Region, few kilometers from the town Gali.

The scope of the Contract includes the rehabilitation of the following facilities:

- 4 km long and 6 m wide concrete road from Tbilisi-Sokhumi road to settlement Rechkhi
- 12 km long section of the 5 m wide unsurfaced inspection road existing along the diversion channels of Vardnili Hydro Power Plants
- renovation of accommodation/office building (around 1500 m<sup>2</sup>) in the settlement Rechkhi

The Client will provide construction designs for the rehabilitation of the roads and accommodation/office facilities.

The rehabilitation of the roads and accommodation/office facilities can be implemented concurrently. The expected construction period is 3-4 months.

Prequalification and tendering for contracts to be financed with the proceeds of a Grant from the European Commission is open to firms and joint ventures of firms from any country.

Prequalification documents may be obtained from the office at the address below or may be dispatched electronically in PDF format free of charge.

The prequalification documents must be duly completed and delivered to the address below, on or before 25 November 2011, by 16:00 PM, local time. Documents which are received late may be rejected and returned unopened.
